Case status is either open or reopened. Select all active Case Participants excluding participants with a Service Role of 'Child Not Receiving Services' who are less than 18 years of age AND does not have an active Family Support Status, Living Arrangement or Out of Home Placement. • Case Type = ICPC, In-Home-Court Order Supervision, Out-Of –Home-Court Ordered, In-Home Voluntary, Out-Of-Home-Voluntary, Young Adults Formerly in Foster Care Age 18-22. Case status is either open or reopened. Active Case Participants with the Service role of 'Child', greater than 18 years of age that do not have an active Living Arrangement or Out of Home Placement. • Out of Home Placement has been created but does not have a Level 2 Approval. <p>EXCLUSIONS: Exclude closed cases for all of these conditions.</p>

Last Face-to-Face Visit			Display most recent Completed Face-to-Face documented on a Note for this person. If the participant does not have a Face-to-Face visit and the Case status is Reopened, leave blank.
Duration Since Last Face-to-Face			Calculate days since last face-to-face visit as of report run date. If the participant does not have a Face-to-Face visit and the Case status is Reopened, leave blank.
Alert			Display Alert type if an Alert with the type of Runaway, Abducted or Absconded exists for the participant.
