7.	The child is in the custody of the Department at the time of intake.

14. Parents, volunteers, advocates, school personnel, medical personnel and others have infrequent contact with the child(ren) as a provider/facility practice or location in the community.
15. There are prior reports involving the facility, regardless of findings.
16. There is a current or prior report involving the death of a child.
