Child Investigations and Special Conditions Summary Report

Functionality Overview

This is a new report that summarizes the detail provided in the Child Investigations and Special Conditional Detail Report.

This report supports drilling into the detailed Child Investigations and Special Conditions Detail Report specified above.

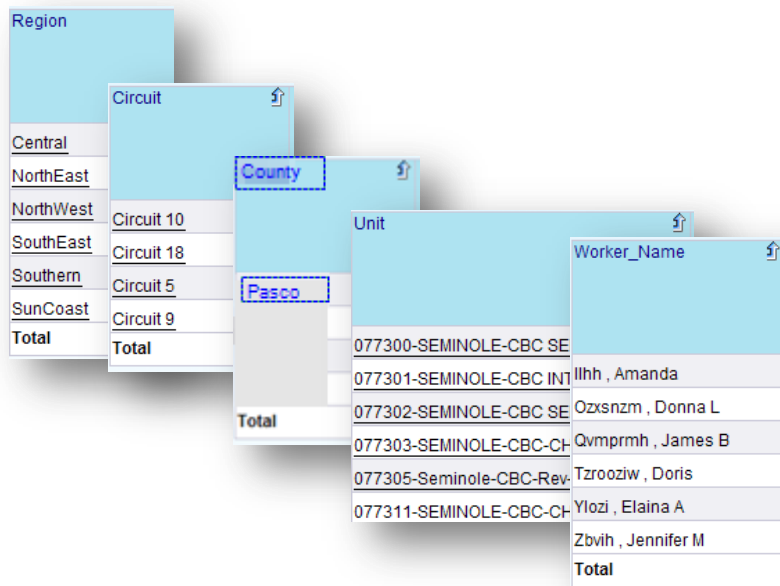


Figure 1: Example of Region, Circuit, County, Unit, Worker Drill Down

The Region, Circuit, County, Unit, and Worker levels are accessed using a drill down approach as illustrated in Figure 1.

The report includes the ability to view whether the investigation was “Pre-Transformation” versus “Post-Transformation”.

This report runs several times a day and generates a notification to the group of users identified as the audience for this report. These scheduled runs are stored historically.

Selection Processing

This report selects data based on the following criteria.
