SUBJECT: Review Team Members for the Child and Family Services Review

PURPOSE: This is to follow up on the October 29th memo that informed you of the sites selected for the upcoming Child and Family Services Review (CFSR) in Miami-Dade, Seminole County, and Alachua County the week of January 7, 2008.

BACKGROUND: You will recall that in July we asked for your help in identifying individuals familiar with child welfare and the CFSR process who would be willing to serve as state reviewers in partnership with federal reviewers at each of the designated sites. The response was very good. We have since assembled teams that include staff from various program components within the Department, CBCs, Court Improvement, Coalitions, and a county sheriff's office. In addition, we have established a list of alternates should someone not be able to serve for unforeseen reasons.

You will find the review teams list attached, including the state's team leads, reviewers and local site coordinators for each site.

As mentioned in the October 29th memo, the sample selection process is underway; we expect to have each site's list in a couple of weeks.

Local site coordinators are managing preparation and logistical activities preceding the on-sites. Overnight accommodations have been arranged for the Miami-Dade teams, but Administration for Children and Families (ACF) is still working on locating hotels in Alachua and Seminole Counties. Additional information will be provided to team members once those decisions are made.

ACTION REQUIRED: All reviewers and team leads must attend the prerequisite training provided by ACF which is scheduled for December 17-18 at the Marriott Tampa Waterside Hotel, 700 South Florida Avenue, Tampa, FL.

Please assist by ensuring review team members under your administration are able to attend the training and are relieved of their normal duties the entire week of January 7th so that their full attention can be given to this intensive process. Also, please share this information with lead agencies in your respective areas.
